Bids must be received by no later than the time and date specified in the Tender document. In the event of the specified date for the submission of Bids being declared a holiday for Sikkim, the Bids will be received up to the appointed time on the next working day.

**9. Late Bids**

Any bid received after the deadline for submission of bids as prescribed will be rejected and/or returned unopened to the Bidder.

**10. Right to Accept or reject any or all Applications/Bids**

Notwithstanding anything contained in this tender Document, the Agriculture Department reserves the right to accept or reject any Application/Bid and to annul the Bidding Process and reject all Applications/ Bids, at any time without any liability or any obligation for such acceptance, rejection or annulment, and without assigning any reasons therefore. In the event that the Agriculture Department rejects or annuls all the Bids, it may, in its discretion, invite all eligible Bidders to submit fresh Bids hereunder.

The Agriculture Department reserves the right to reject any Application and/ or Bid if:

- a. At any time, a material misrepresentation is made or uncovered, or
- b. The Applicant does not provide, within the time specified by the Department, the supplemental information sought by the department for evaluation of the Application.
